O.P.H.A. HORSE SHOW POINT SYSTEM RULE

1. Owners, lessees, and equitation riders must be current members of the O.P.H.A. at the time the points are won for the points to count toward year-end awards.
2. Points remain with the horse when bought or sold, providing that new owner is a member of the O.P.H.A.
3. Each year's point system begins on December 1st and is in effect through the following calendar year's Fall O.P.H.A. show; which shall be the last show of the year.
4. Fifteen dollars must be sent for each horse with a nomination form before points will be counted toward yearly awards. This will be used to defray the cost of awards and expenses.
5. Nominating and membership forms will be available at each show, at meetings, on the website (www.opha.org), or by sending a stamped, self-addressed envelope to the **Membership** Secretary.
6. Points will be counted as follows:

1st place.....	10 points	4th place.....	2 points
2nd place	6 points	5th place.....	1 point
3rd place.....	4 points	6th place.....	1/2 point

7. Effective December 1, 1994, points will be determined according to the number of entries in the first class over fences in each section. Sections with 3 to 11 entries will receive single points; 12 to 17 entries shall receive double points; and 18 or more entries shall receive triple points. This system shall apply to all O.P.H.A. approved shows regardless of USEF rating or location.

CLASSES & DESCRIPTIONS

In order to qualify for points for the annual O.P.H.A. Championship and/or High Score Awards, the **minimum height** for fences must be observed in each division. All O.P.H.A. divisions and classes will be run in accordance with O.P.H.A. rules. A nominated horse or pony must compete in its respective division at a minimum of three horse shows per year for points to count toward year-end awards. When a division is required to be held over two days (only at USEF AA & A [Premier and National] shows) and entry requires payment with a division fee (High Performance, Green, Amateur Owner, Junior, Pony, and Green Pony), if there are fewer than three (3) exhibitors on the second day, OPHA points will count.

Regardless of the number of entries in the first class over fences, the OPHA will sanction any class to count for year-end awards only if a minimum of three entries have competed. In classes over fences, “competed” means that the first fence has been judged with a score recorded on the judge’s card. In flat classes, “competed” means that three entries have been judged (are shown as having been in the ring on the judge’s card, regardless of whether they receive an award).

Exceptions: (1) If there are enough exhibitors to split a division in the first performance class and fewer than three exhibitors in subsequent classes OPHA points will count. (2) NARHA and Fox Smith Medals as described below. (3) There is no minimum for Hunter Breeding classes.

When a division is required to be held over two days (only at USEF AA & A [Premier and National] shows) and entry requires payment with a division fee (High Performance, Green, Amateur Owner, Junior, Pony, and Green Pony), if there are fewer than three (3) exhibitors on the second day, OPHA points will count.

In compliance with USEF ruling on headgear, all juniors riding in Hunter, Jumper and Hunter Seat Equitation sections at OPHA shows may not ride anywhere on the show grounds without protective headgear (including harness secured and properly fitted) passing current USEF standards. Any rider violating this

rule at any time will be prohibited from further riding until headgear is properly in place. All riders competing or schooling over fences must wear ASTM/SEI approved protective headgear.

Please also refer to the current USEF and USHJA Zone 5 Rule Books for any further clarifications.

VERY GREEN HUNTER: Open to horses and ponies in their first year of showing over fences at 2'6". Fences 2'6". Horses and ponies may not cross enter into any class with fences higher than 3' at the same show and may only receive points in this section for one year.a

GREEN HUNTER 3' AND 3'3": A 3' / 3'3" Green Hunter is a horse of any age in its first or second year of showing over 3' to 3'3" fences at USEF Regular Member or Canadian Equestrian Federation shows or any national or international competition. Horses may only compete in one height section at a show, but may alternate from one show to another. Once a horse has shown 3'6" he is not eligible to compete in the Green Hunter 3' section. A horse is still eligible for the 3'3" section until it competes at 3'6" for the fifth time, then it becomes a 3'6" Green Hunter. Horses nominated for OPHA awards may only receive points in this division for two years. See USEF & USHJA Rule Books for additional specifications.

GREEN HUNTER 3'6" AND 3'9": Horses nominated for High Score Awards may receive points in this division for two years: once as a 3'6" horse and once as a 3'9" horse. See USEF & USHJA Rule Books for additional specifications.

HIGH PERFORMANCE HUNTER: Horses are not restricted by age or showing experience. See USEF & USHJA Rule Books for class specifications. Fences 3'6" to 4'.

PERFORMANCE HUNTER: Individual classes may be entered. See USEF & USHJA Rule Books for class specifications. Fences 3'3" or 3'6".

LOW ADULT HUNTER: Open to amateur riders. Cross entry between the Low Adult section and the Amateur Owner section is prohibited. **Same horse/rider combination may nominate for only one of the following: Low Adult Hunter, Adult Amateur Hunter, Amateur Owner Hunter.** Fences 2'6".

ADULT AMATEUR HUNTER: Horses to be ridden by amateurs. Riders may not compete in any other classes at the same competition where fences exceed 3'5" (Equitation, Jumper classes 1.20m and lower, Amateur Owner Hunter, Amateur Owner Jumper classes, and the USHJA International Hunter Derby). Any rider showing in the Amateur Owner Hunter or Amateur Owner Jumper division may compete with 1 different horse in the Adult Amateur Hunter division and must own or have a USEF lease of said horse. Fences 3', spreads not to exceed fence heights. Ponies may be shown by Adults, suitability to count. An unrestricted Children's/Adult Hunter division may be offered open to all Amateurs and Juniors, with fences not to exceed 3'3". **Same horse/rider combination may nominate for only one of the following: Low Adult Hunter, Adult Amateur Hunter, Amateur Owner Hunter.**

AMATEUR OWNER HUNTER: See USEF & USHJA Rule Books for class specifications. Fences 3'3" or 3'6".

ADULT EQUITATION ON THE FLAT: Open to all amateur riders.

LOW ADULT EQUITATION ON THE FLAT: Open to amateur riders. Rider may nominate for points in only this class *or* the Adult Equitation on the Flat.

N.A.R.H.A. ADULT EQUITATION: Open to all Amateur members, a rider may not compete at the same horse show in any hunter or equitation class in which the jumps exceed three feet, three inches (3'3"). To be shown over a minimum of eight fences 2'9" to 3' in height, spread not to exceed fence height. The course may be either a hunter or jumper type and must include at least two changes of direction and a combination. Water obstacles are not permitted. A numerical score must be announced at the completion of the first round. Top four riders are required to return for further testing. There is no minimum requirement to fill the class. If a show does not offer a separate N.A.R.H.A. class, Ariat points will count as N.A.R.H.A. points.

JUNIOR WORKING HUNTER: See USEF & USHJA Rule Books for class specifications. Fences 3'3" or 3'6".

THE O.P.H.A. HUNTER SEAT MEDAL: Open to Junior members who have not yet reached their 18th birthday. To be shown over a course of not less than 8 fences at 3'6", with two changes of direction. In addition, the course must include at least two of the following: an in and out, an end jump, a narrow

jump, a wingless jump, a broken line, a roll back, a triple combination, a bounce. Additional testing of the top four riders is required; test(s) are at the judge's discretion. To fill the class, three competitors must complete the course. Horses need not be nominated.

CHILDREN'S HUNTER: To be ridden by a Junior exhibitor. Riders may not cross enter into any class in which fences exceed 3'5" at the same show, (Exception: Equitation classes up to 3'9", Jumper classes 1.20m and lower, Junior Hunter sections and USHJA International Hunter Derby). Fences 3, spreads not to exceed fence height. Rider restrictions: A Children's Hunter Horse rider may only compete one different horse in the Junior Hunter Sections. A Junior Hunter rider may only compete one different horse in the Children's Hunter Horse section. Riders entered in the Children's Hunter Horse section may only compete on one Children's Hunter Pony at the same competition.

CHILDREN'S EQUITATION ON THE FLAT: Open to all riders eligible for the Children's Hunter section.

FOX SMITH MEMORIAL MEDAL CLASS: Open to all Junior members. To be shown over a minimum of eight fences 2'9" to 3' in height, spreads not to exceed fence height. The course may be either a hunter or jumper type and must include at least two changes of direction and a combination. Water obstacles are not permitted. A numerical score must be announced at the completion of the first round. Top four riders are required to return for further testing. There is no minimum requirement to fill the class. Horses need not be nominated. T.H.I.S. National Children's Medal points count for Fox Smith points.

LOW CHILDREN'S HUNTER: To be ridden by a junior exhibitor. Fences 2'6". Riders may not cross enter into any class on the same horse in which fences exceed 2'6" or in any class where fences exceed 3'3".

LOW CHILDREN'S EQUITATION ON THE FLAT: Open to all riders eligible for the Low Childrens Hunter section.

Note: Ponies shown by a junior in any pony division (Pony Hunter, Green Pony Hunter, Children's Pony Hunter) cannot be shown by an adult at the same competition, except in breeding classes in-hand.

CHILDREN'S HUNTER PONY: Open to ponies ridden by a Junior exhibitor. Riders competing in the Children's Hunter Pony section are not limited to the number of ponies they may

show, providing they are not also competing in the Green or Regular Hunter Pony sections and/or Children's Hunter Horse section at the same competition, except in competitions with their own entry restrictions. Children's Hunter Pony riders are limited to competing a maximum of one (1) different pony in the Green or Regular Pony Hunter section and one (1) horse in the Children's Hunter horse section at the same competition and in any class not to exceed 3'5". Fences 2' for small and medium and 2'6" for large ponies; spreads not to exceed fence height.

CHILDREN'S PONY EQUITATION ON THE FLAT: Open to all riders eligible for the Children's Pony Hunter Section. Rider may nominate for points in only this class or the Pony Equitation on the Flat class.

GREEN PONY HUNTER: A Green Pony Hunter is a pony not exceeding 14.2 hands, of any age, in its first year of showing in any classes that require ponies to jump the regulation height or higher in their respective sections (2'3" small, 2'6" medium, 2'9" large).

PONY HUNTER: OPHA shows offering the Pony Hunter division will be required to change the distances of in and outs and lines less than 100 feet to accommodate the different size of pony strides. Fences 2'3" small, 2'6" medium, 2'9" to 3' large. The exhibitor may be asked to validate the size of the pony.

PONY EQUITATION ON THE FLAT: Open to all riders eligible for the Pony Hunter section.

DICK GASCOIGNE MEMORIAL PONY MEDAL: Open to riders eligible for the Pony Hunter division. To be shown over a course of not less than six obstacles at fence heights 2'3" small, 2'6" medium, 2'9" to 3' large. Two tests (USEF 1 – 9) are required during the first round. Only one rider per pony permitted. To fill the class, 3 competitors must complete the course. Ponies need not be nominated. USEF Pony Medal points count for Gascoigne points.

SHORT STIRRUP: Open to riders 12 years of age and under. Riders may not cross enter into any other OPHA recognized section at the same show except age appropriate under saddle classes. Points received in all classes go with the rider; however, the horse must be nominated. If a rider shows more than one horse or pony in the Short Stirrup division at the same show, only the highest scoring mount's points will be awarded to that rider for that show. Fences 2', oxers and in & outs not permitted.

SHORT STIRRUP EQUITATION ON THE FLAT: Open to riders eligible for the Short Stirrup division.

INTERMEDIATE CHILDRENS/ADULT JUMPER: Open to junior/amateur riders. Fence height 2'9" – 3'. The horse/rider combination may not cross enter into any class at the same show with fences higher than 3'3". Horse/rider combination must stay the same within a competition.

LOW CHILDRENS/ADULT JUMPER: Open to junior/ amateur riders. Fence heights to be set at 1.00 m (3'3"). Riders may not cross enter into any classes held above 1.15 m (3'9") at the same competition. Horse/rider combinations may cross enter into the Children's/Adult Amateur Jumpers at the same show. Horse/rider combinations may enter only one classic, if both Low and High are offered.

CHILDREN'S JUMPER: Open to horses and ponies ridden by a junior exhibitor. Horse/rider combinations may not cross enter into any Junior Jumper section at the same show. Riders may cross enter into the Low Junior Jumper section on a different horse. Riders may not compete above 1.30 m (4'3") in any open class at the same show. Sections may be divided by age of rider or by horse/pony, and may be combined with Adult Jumper if so stated in prize list. Fences 1.10 m (3'6"); shows may offer 1 class at 1.15 m (3'9").

JUNIOR JUMPER: See USEF & USHJA Rule Books for class specifications. Fences 1.15 m to 1.25 m (3'9" to 4').

ADULT JUMPER: Open to horses and ponies ridden by Amateurs. All exhibitors must show USEF amateur certification. Horse/rider combinations may not cross enter into any Amateur Owner Jumper section at the same show. Riders may cross enter into the Low Amateur Owner Jumper section on a different horse at the same show. Riders may not compete above 1.30 m (4'3") in any open class at the same show. Sections may be divided by age of rider or horse/pony and may be combined with Children's Jumper if so stated in prize list. Fences 1.10 m (3'6"); shows may offer 1 class at 1.15 m (3'9").

AMATEUR JUMPER: See USEF & USHJA Rule Books for class specifications. Fences 1.15 m to 1.25 m (3'9" to 4').

OPEN JUMPER: At shows that do not offer Open Jumper classes; but do offer Modified Jumper classes with no restriction on eligibility; those Modified Jumper points will count toward

the Open Jumper year-end award. Fences 1.15 m to 1.55 m (3'9" to 5').

HUNTER BREEDING: See current USEF Rule Book for individual class specifications.

SPECIAL CLASSES: Hunter and Jumper Classics and other special classes will be awarded OPHA points, provided the class in no way restricts entries (by requiring membership in a particular association, for example). Mini-prix and other classes open to all jumpers will be awarded open jumper points.

SCHOOLING SHOWS

CLASS DESCRIPTIONS & RULES

The OPHA will sanction a limited number of schooling shows during the year which will offer at least three of the following divisions: **Walk/ Trot X-Rails, Walk/Trot/Canter X-Rails, Limit Rider, Novice Rider.**

Points needed to receive year-end awards are:

Gold = 50, Silver = 30, Bronze = 17.

These classes are geared toward riders in a lesson program who are just starting to go to horse shows, or moving up in level of difficulty. Safe, simple courses are recommended. Emphasis will be placed on suitability of mount to rider's ability level. Safety will be the foremost concern in these classes. Demonstrating control of mount is extremely important. Excessive speed will be penalized and may cause elimination from the show ring.

Horses and riders in the Schooling Divisions must follow current USEF tack and equipment rules, except standing martingales will be permitted in all divisions.

WALK/TROT X-RAILS: Open to all ages. There must be a minimum of four (4) fences. Ground lines are required. Flower boxes and brush boxes are optional.

WALK/TROT/CANTER X-RAILS: Open to all ages. There must be a minimum of four (4) fences. Ground lines are required. Flower boxes and brush boxes are optional.

LIMIT RIDER: Fences 1'6" to 2'. Oxers not permitted.

NOVICE RIDER: Fences 2'3" to 2'6". Oxers optional.

The following will receive points toward year-end awards as outlined in Article VI, sections 6 and 7.

Schooling Rider Medal

Open to riders of all ages participating in Limit or Novice Rider; ponies must be ridden by a junior. Fences offered at 2' and 2'6" (oxers not permitted). Distances to be set as per all other 2' and 2'6" divisions.

RULES

1. In order to receive points for High Score Honors riders must be current members and must be nominated. Horses need not be nominated.
2. Riders nominated for other OPHA rated divisions are not eligible for Schooling Show High Score Honors.
3. Points will not carry from one division to the next. The rider will, however, be eligible for year-end awards in **two** chronological divisions at the same time.
4. A riders age will be determined according to USEF rules – age as of December 1st of the current competition year.
5. The OPHA will recognize a limited number of Schooling Shows per year. Other OPHA shows may offer any or all of the Schooling Show Divisions, but points will not count toward year-end awards.
6. Horse shows applying for OPHA Schooling Show recognition must offer at least 3 of the 4 listed divisions.
7. There will be two over fences, one under saddle, and one flat equitation class in each division. It is recommended that all four classes count equally toward the Championship.
8. In Novice Rider and Limit Rider, at least 3 entries per class must complete the course or class for points to count. For WALK/TROT X-RAILS and WALK/TROT/CANTER X-RAILS **ONLY**, exhibitors will receive points if 2 exhibitors complete the course or class.
9. Points will follow the **rider** in all divisions. If a rider shows more than one mount in a Schooling Show section, only the highest scoring mount's points will count for that rider at that show.

JUDGING

1. Standing martingales **will** be permitted in all classes.
2. Only six to canter at one time in Walk/Trot/Canter divisions.
3. Riders in Walk/Trot X-Rails may trot in and canter out of lines, but should exhibit control and return to the trot before the next line.
4. In the Walk/Trot/Canter, Limit and Novice sections, trotting to obtain a simple change of lead is permitted and is not to be penalized.

O.P.H.A. HORSE SHOW REQUIREMENTS

ATTENTION HORSE SHOW MANAGERS: The following specifications must be met in order to be an OPHA approved show and to have points count toward the year-end high score awards.

1. All horse show dates must be applied for in writing on the appropriate form, available online at OPHA.org, and submitted with payment of \$50 per show to OPHA, P. O. Box 23421, Chagrin Falls, OH 44023. Address labels for mailings to members available on request.
2. Any horse shows wishing OPHA approval must apply in writing on the appropriate form.
3. A check for \$50.00 made payable to the OPHA must be sent to the OPHA Championship Point Secretary **at least 30 days prior** to the date of the show.
4. Prize list and show results, including number of entries in OPHA rated classes, must be sent to the OPHA Championship Point Secretary, **within 10 days** of the close of the show. Failure to send results will incur a \$100.00 fine. Failure to return results within three months will prevent next year's protected date approval.
5. Only one OPHA rated show will be allowed within 75 miles on the same day **unless** the party holding the protected show date agrees to waive the restriction.
6. It is recommended that all OPHA shows have a USEF Recorded or Registered judge. Shows that are not USEF sanctioned may select from our OPHA Approved Judges list, consisting of Professional Horsemen. Request for permission to use a judge that is not listed on the "approved judges" list must be made at least 90 days in advance. Only a Professional Horseman may be requested. This list is located on our website (www.opha.org) under docs & forms.
7. Loss of points for failure to meet the above requirements is the responsibility of horse show management.
8. Any extraordinary circumstances on date approvals or changes will be handled by the Horse Show Committee.
